July 2017 onwards updates: The ADA Pre Assessment Screening Service:

How can I access the pre assessment screening service for the month of June?

The ADA pre assessment service is currently available from July 2017 as a service to all. The fee presently is \$120.00 under the existing website. If you would like to take this service up, please email ADA and request an invoice for a non member pre assessment. Please include, name for invoice, age of individual and your email please. ADA will then prepare this for you and email you. You can also request this via the **ADA text service 0410 850 185**

How is the pre assessment delivered (currently)?

Until the new website is up the pre assessment is delivered to you via email. It is prepared precisely for your child, teen or adult's age group. The pre assessment screening is aligned with research screening procedures. The ADA pre assessment is thorough, it is designed to collect pertinent information along with student input samples. The ADA pre assessment service is devised specially by the ADA and is based on an inclusionary researched based approach, it is NOT a commercially bought product. ADA will email the package to you so there is no need to make a face to face appointment.

Where do I presently post the completed pre assessment documents to?

Please note ADA is an Australian Registrable body (ABRN) with government (ASICs) and operates legally in every state of Australia. ADA office locations include Sydney and Melbourne.

How long do the results take once ADA receive them?

The ADA pre assessment documents are evaluated carefully by ADA trained and highly experienced ADA assessors. The evaluation generally takes around 3-7 working days however delays can occur when demand reaches a peak. Results will be emailed. You will receive a two page report with results of the ADA pre assessment screening. Additional relevant attachments are included for home and school. Please note ADA follow school holidays and public holidays.

How does the ADA pre assessment differ to a full assessment?

The ADA pre assessment screening is a valuable and highly recommended step in identifying dyslexia and or dysgraphia. The ADA pre assessment screening is a sensible step as it avoids unnecessary upfront full 'testing' or 'over testing' often associated with higher fees. Many schools, parents and adults can be identified and assisted at the ADA screening stage. The ADA pre assessment includes a clear outcome (2 page report) along with relevant fact sheets to assist all who take up the exclusive ADA screening service. It is service that can help **all** who struggle with aspects of language and literacy for various reasons.
